Invesco Global Clean Energy UCITS ETF (the "Fund") A sub-fund of Invesco Markets II plc (the "Umbrella Fund") Acc (ISIN: IE00BLRB0242) (the "Share Class")

The Fund is managed by Invesco Investment Management Limited, part of the Invesco Group.

Objectives and Investment Policy

- The Fund is a passively-managed Exchange-Traded Fund (ETF), which aims to achieve the net total return performance of the WilderHill New Energy Global Innovation Index (the "Index"), less fees, expenses and transaction costs, thereby taking an approach that seeks to invest in companies whose innovative technologies focus on the generation and use of cleaner energy, conservation, efficiency and the advancement of renewable energy, hence facilitating the transition to a lower carbon economy.
- To achieve the investment objective the Fund will, as far as possible and practicable, hold all the securities in the Index in their respective weightings
- The Fund's shares are listed on one or more Stock Exchange(s). Investors can buy or sell shares daily through an intermediary directly or on Stock Exchange(s) on which the shares are traded. In exceptional circumstances investors will be permitted to redeem their shares directly from Invesco Markets II plc in accordance with the redemption procedures set out in the prospectus, subject to any applicable laws and relevant charges.
- The Fund is an Article 8 Fund (it promotes environmental and/or social characteristics) for the purposes of Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability related disclosures in the financial services sector ("SFDR").
- Fund's base currency is USD.
- Dividend Policy: This Share Class does not pay you income, but instead reinvests it to grow your capital, in line with its stated objectives.
- Net Asset Value: This is calculated daily and the Fund is open for subscriptions and redemptions on each day the United States Federal Reserve System is open. Please refer to the prospectus for further information.
- The Index: The Index tracks the performance of global companies whose innovative technologies focus on the generation and use of cleaner energy, conservation, efficiency and the advancement of renewable energy. It is mainly composed of companies focused in wind, solar, biofuels, hydro, wave, tidal, geothermal and other relevant renewable energy businesses, as well as energy conversion, storage, conservation, efficiency, materials relating to those activities, carbon and greenhouse gas reduction, pollution control, emerging hydrogen and fuel cells. Companies are excluded if they are deemed by the Index provider (using data provided by Sustainalytics) to be involved in certain business activities and severe ESG controversies. Companies are then assessed to determine whether they have meaningful exposure (as determined in accordance with the Index provider's criteria) to one of the following clean energy sectors, as defined by the Index provider: 1)

 Renewable Wind; 2) Renewable -Solar; 3) Renewable Biofuels & Biomass; 4) Renewables Other; 5) Energy Efficiency; 6) Energy Conversion; and 7) Energy Storage. In accordance with the Index methodology, Companies are excluded from the Index that are: (a) not compliant and in violation of international norms and standards; (b) identified to have a severe controversy rating; and/or (c) engaged, from a business involvement perspective, in a number of harmful activities and products (as more fully set out for each exclusion in the methodology of the Index). Such exclusions may vary depending on the activity, from zero tolerance to exclusions based on percentage of revenue or other measures as more fully set out in the methodology for the Index. Securities must also meet certain liquidity and tradability criteria to be eligible for inclusion in the Index. The index is calculated by equally weighting each security. The Index is rebalanced quarterly.

Other Risks


- General Investment Risk: The value of investments, and income from them, can go down as well as up and you may not get back the full amount you invested.

- Securities lending: The Fund may be exposed to the risk of the borrower defaulting on its obligation to return the securities at the end of the loan period and of being unable to sell the collateral provided to it if the borrower defaults.
- Small Companies: As this fund invests primarily in small companies, investors should be prepared to accept a higher degree of risk than for an ETF with a broader investment mandate.
- Clean energy risk: Investments into the clean energy sector are considerably exposed
 to investment trends focused on environmental factors and may have sensitivities
 towards ESG related government regulation and tax implications.

- *Currently, the Fund is not exercising its entitlement to apply entry and exit charges.
- The **ongoing charge** is based on the fee paid to the Manager. The Manager is responsible for discharging from its fee, costs attributable to the Investment Manager, Administrator, Depositary as well as the Operational Expenses incurred by the Fund. It excludes portfolio transaction costs except in the case of an entry or exit charge paid by the Fund when buying or selling shares/units in another fund.
- Because the Fund is an ETF, investors will typically only be able to buy or sell shares in the secondary market. Accordingly, investors may incur brokerage and / or transaction fees in connection with their dealings. Investors may also bear the costs of "bid-ask" spreads; meaning the difference between the prices at which shares can be bought and sold. You should discuss these fees and costs with your broker before you invest, as they may reduce the amount of your initial investment and the amount you receive on disposal.
- The Fund may engage in securities lending, whereby 90% of the revenues arising from securities lending will be returned to the Fund and 10% of the revenues will be retained by the securities lending agent.
