#### **Objectives**

WisdomTree Physical Precious Metals is backed by physical, allocated Physical Precious Metals held by HSBC Bank plc (the custodian). Only metal that conforms with the London Bullion Market Association's (LBMA) and London Platinum and Palladium Association's (LPPM) rules for Good Delivery can be accepted by the custodian. Each physical bar is segregated, individually identified and allocated. For example, if Physical Precious Metals rises by 1% over a day, then the ETC will rise by 1%, excluding fees.

# What are the risks and what could I get in return?
