Objectives and investment policy

The fund is passively managed. INVESTMENT OBJECTIVE: The aim is for your investment to reflect the performance of the Euro STOXX® QUALITY DIVIDEND 50 index (index) which is designed to reflect the performance of 50 high quality, high dividend-paying and low volatility shares within the Euro STOXX® index (Base index). DESCRIPTION OF INDEX: The shares are selected using a screening process which involves analysing data for each constituent (such as levels of dividends paid out, volatility and income growth rates). Scores are allocated to the universe of eligible constituents based on predefined metrics. The final 50 constituents are selected (with a maximum of 15 per industry) and weighted subject to a 4% cap per constituent. INDEX REBALANCING, CALCULATION AND ADMINISTRATION: The index is calculated on a total return net basis which means that all dividends and distributions by the companies are reinvested in the shares after tax. The index is reviewed on a semi-annual basis. INVESTMENT POLICY: To achieve the aim, the fund will attempt to replicate the index, before fees and expenses, by buying all or a substantial number of the securities in the index. The fund may employ techniques and instruments in order to manage risk, reduce costs and improve results. These techniques and instruments may include the use of financial contracts (derivatives). The fund may also engage in secured lending of its investments to certain eligible third parties to generate additional income to offset the costs of the fund. You may request the redemption of shares generally on a daily basis.



To the extent the fund undertakes securities lending to generate revenue, the fund will ultimately be allocated 82% of the associated revenue, the securities lending agent, which will be a Deutsche Bank entity, will be allocated 9% and the remaining 9% will be allocated to the DWS entity which monitors such activities, as set out in the sales prospectus and/or supplement, for its own coordination and oversight tasks. As securities lending revenue sharing does not increase the costs of running the fund, this has been excluded from the composition of costs.
