

## Objectives and investment policy

The fund is passively managed. INVESTMENT OBJECTIVE: The aim is for your investment to reflect the performance of the S&P/ASX 200 TR index (index) which is designed to reflect the performance of shares of the 200 largest companies listed on the Australian Securities Exchange. DESCRIPTION OF INDEX: Companies are selected based on their size and the volume of trading in their shares. A company's weighting in the index depends on its relative size based on the combined value of a company's readily available shares as compared to other companies. The composition of the index is reviewed every quarter. INDEX REBALANCING, CALCULATION AND ADMINISTRATION: The index is calculated on a gross total return basis which means that all dividends and distributions by the companies are reinvested in the shares. INVESTMENT POLICY: To achieve the aim, the fund will attempt to replicate the index by buying all or a substantial number of the securities in the index. The fund may employ

techniques and instruments in order to manage risk, reduce costs and improve results. These techniques and instruments may include the use of derivatives. The fund may also engage in secured lending of its investments to certain eligible third parties to generate additional income to offset the costs of the fund. ### Risk and reward profile



To the extent the fund undertakes securities lending to generate revenue, the fund will ultimately be allocated 82% of the associated revenue, the securities lending agent, which will be a Deutsche Bank entity, will be allocated 9% and the remaining 9% will be allocated to the DWS entity which monitors such activities, as set out in the sales prospectus and/or supplement, for its own coordination and oversight tasks. As securities lending revenue sharing does not increase the costs of running the fund, this has been excluded from the composition of costs.
