## What is this product?

**Type:**

This product is a physically backed exchange traded certificate. These are secured, limited recourse certificates.

**Term:**

This product has a final maturity date of 31 December 2100. The Manufacturer has the right to terminate the product in a limited number of circumstances, as set out in the prospectus.

**Objectives:**

The Invesco Physical Gold GBP Hedged ETC aims to provide the performance of the spot gold price through certificates collateralised with gold bullion.

The base currency is GBP.

The product includes a foreign exchange hedge to reduce the exposure of the certificates to exchange rate fluctuations between GBP and USD, the currency in which the underlying precious metal is typically quoted.

**Intended Retail Investor:**

This product is intended for investors who (i) have sufficient knowledge and experience to make a meaningful evaluation of the merits and risks of investing in the certificates; (ii) are willing to invest for a medium to long term; and (iii) have financial resources to bear all the risks associated with this product including loss of original capital.

## What are the risks and what could I get in return?

**Risk Indicator**



The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the ability for you to receive a positive return on your investment.

## How long should I hold it and can I take money out early?

**Recommended holding period: 5 years**

This product has no required minimum holding period however we have selected 5 years as the recommended holding period as the product invests for the medium to long term therefore you should be prepared to stay invested for at least 5 years.

You can sell your shares in the product during this period, subject to satisfying certain criteria as set out in the prospectus, or hold the investment longer. If you sell some or all of your investment before 5 years your investment will be less likely to achieve its objectives, however, you will not incur any additional costs by doing so.
